

37 One thousand three hundred eighty-seven dollars and no cents (\$1387.00) shall be appropriated to the account of the
38 Plant and Environmental Sciences Graduate Student Organization from the ASNMSU Surplus Account.

40Section 4: Rationale.

41 Three students Alison, Amol and Sudhir are going to present their research at the American Society of
42 Agronomy, crop Science Society of America & Soil Science Society of America (ASA, CSSA, & SSSA)
43 annual meeting in Long Beach.

44 Alison is presenting her research about the utilization of reverse osmosis wastewater in the agricultural
45 irrigation of salt tolerant plants.

46 Amol is presenting his PhD research about evaluation of Anthocyanin content from Native-Blue corn
47 landraces. Native-Blue corn landraces are known for their nutritional value and this landraces have been
48 used as a "Functional Food" by local Native-Indian community.

49 Sudhir is presenting his master research for guar crop (*Cyamopsis tetragonoloba* L.) and adaptability in
50 New Mexico. Work is concentrated about best planting time and variety for guar.

51 All the three students are from different research groups from the same department. They are travelling on
52 different times, staying for different number of days and in different hotels. That's the reason for three
53 different lodging.

54 The registration fee includes the registration (\$270) and abstract submission fee (\$30).
