

A RESOLUTION

1 CONCERNING THE HOURLY COMPENSATION OF THE ASNMSU CHIEF SENATE CLERK AS EXPRESSED IN
2 THE 2016-2017 ASNMSU LAW BOOK. BE IT RESOLVED BY THE SENATE OF THE ASSOCIATED STUDENTS OF
3 NEW MEXICO STATE UNIVERSITY.

5 WHEREAS the ASNMSU Chief Clerk has extensive duties as outlined in section 8-5-B of the 2016-2017 ASNMSU Law
6 Book; and

8 WHEREAS the ASNMSU Chief Senate Clerk is only allotted sixty (60) hours per month, which is equal to fifteen (15) hours
9 per week, to complete said duties; and

10

11 WHEREAS this is not sufficient time to complete the duties required of the Chief Senate Clerk; and

12

13 WHEREAS every other paid position within ASNMSU is allotted at least eighty (80) hours per month, which is equal to
14 twenty (20) hours per week, to complete their duties; and

15

16 WHEREAS the General Appropriations Act for Fiscal Year 2016-2017 allocates compensation for eighty (80) hours per
17 month's (twenty (20) hours per week) for the ASNMSU Chief Senate Clerk.

19 THEREFORE BE IT RESOLVED that the Rules of the Senate, specifically section 8-5-1 of the 2016-2017 ASNMSU Law
20 Book, be revised to accurately reflect the Chief Senate Clerk's compensation for eighty (80) hours per month (20 hours per
21 week); and that the 2016-2017 ASNMSU Law Book be amended with deleted material in [brackets] and inserted material
22 underlined as such:

24 **8-5. CHIEF SENATE CLERK**

28 **8-5-1. SALARY LIMIT FOR THE CHIEF SENATE CLERK**

29 The ASNMSU Chief Senate Clerk shall receive [a salary] compensation not to exceed the wage determined
30 by the General Appropriations Act (GAA) (as allowed by Title [51] 29 of the U.S. code) plus the
31 ASNMSU wage adjustment factor for [sixty (60) hours per month] a .5 Full-time Equivalent (FTE) while
32 performing the duties of the Chief Senate Clerk.
