



38 compete and has done very well. At the competition they have exceeded in: CSI Investigation, Quiz Bowl,
39 and STAR Chapter. In addition, this Conference enhances the students' experiences as Criminal Justice
40 majors through hands on competition such as the CSI Investigation and provides the students an
41 opportunity to network with other college students and Academy of Criminal Justice Sciences (ACJS)
