

1 MAKING AN APPROPRIATION TO THE ACCOUNT OF COLLEGIATE FUTURE FARMERS OF AMERICA. BE IT
2 ENACTED BY THE SENATE OF THE ASSOCIATED STUDENTS OF NEW MEXICO STATE UNIVERSITY.

5 To provide funding for eight students (4 males, 4 females) to compete at the 90th National FFA Convention and
6 Expo in Indianapolis, IN from October 25 – 28, 2017.
