39 American Quarter Horse Congress in Columbus, OH. The students will be traveling to demonstrate their
40 knowledge of equine species and industry, and to exhibit their communication and decision-making skills
41 gained through horse judging. They will be representing NMSU at a national level as they will compete
42 against other students from land grant universities across the United States. The students have been
43 practicing for a year to prepare for this competition and have grown in their professional skills through this
44 club.
