20 A. Funds may be allocated to any recognized student organization that requires its members to pay dues to  
21 fulfill any local or national mandate. ASNMSU funds cannot be used to pay these dues.

23 1. ASNMSU funds may be used to fund for membership fee(s) provided such a fee brings down the  
24 cost of the registration fee for the trip being reimbursed, and the combined membership fee and  
25 registration fee is lower than the original non-member registration fee.

27 a. The Chair of the Senate Finance Committee shall verify that the combined membership  
28 fee and registration fee is lower than the original non-member registration fee.

31 7-4-3-A-1: The purpose of this amendment is to allow the ASNMSU Senate to fund for membership fees, should it  
be used to reduce the registration fee.
