

57 One thousand three hundred eighty-four dollars and no cents (\$1384.00) shall be appropriated to the account of  
58 Counseling Masters Student Association (CMSA) from the ASNMSU Surplus Account.

60 Section 4: Rationale.

61 Subsection A: Dora Caro is a graduate student in the Dept of Counseling and is requesting funding to present at the  
62 American Counseling Association 66<sup>th</sup> Annual Conference and Expo in Atlanta, GA from April 25 – 29, 2018. Dora  
63 is traveling earlier than the remaining constituents and hence is requesting funding for the travel to the airport and to  
64 park their car at the airport for 6 days (the reason for traveling earlier is that Dora will be volunteering at the  
65 conference and hence has received \$122.50 discount on the registration fee), airfare to and from Atlanta (which is a  
66 little more expensive since they are traveling earlier), lodging with Air BnB house for 5 nights (the other  
67 constituents will also stay at the same house), two baggage fees (one bag to go and come back), and an estimate of  
68 \$100.00 for travel within Atlanta.

70 Subsection B: Jose Cera, Jessica Smith, and Karsyn Lahann are graduate students in the Dept of Counseling and are  
71 requesting funding to attend the American Counseling Association 66<sup>th</sup> Annual Conference and Expo in Atlanta, GA  
72 from April 25 – 29, 2018. They are requesting funding for the travel to the airport, airfare to and from Atlanta, six  
73 baggage fees (three bags to go and come back), and an estimate of \$200.00 for travel within Atlanta.
