30 Section 4: Rationale.

31 Marcus Sanchez is a member of the NMSU Model United Nations Team who will be involved in an  
32 international community service project titled "Supporting Efforts to Stop Child Labor" in Accra, Ghana  
33 during the summer of 2018. This project will engage them in international human rights advocacy, with  
34 them actively working within the community in Accra to advocate on behalf of child laborers and push for  
35 government and civil society reforms aimed at mitigating, and eventually eliminating, the use of child labor  
36 for development efforts.
