

A RESOLUTION

1 CONCERNING THE ENFORCEMENT OF THE ASNMSU CODE OF ETHICS AND AMENDMENTS TO APPENDIX B
2 OF THE 2018-2019 ASNMSU LAW BOOK.

4 WHEREAS, the Senate of Associated Students of New Mexico State University (ASNMSU) recognizes
5 that respecting the dignity of every person is essential; and

6

7 WHEREAS, the Senate of ASNMSU strongly affirms that enforcement of the ASNMSU Code of Ethics is
8 essential in order to commit to the Mission and Goals of serving NMSU students; and

9

10 WHEREAS, currently no procedure is outlined in the ASNMSU Code of Ethics for reporting a violation;
11 and

13 THEREFORE BE IT RESOLVED by the Senate of the Associated Students of New Mexico State University will not tolerate
14 the violation of the ASNMSU Code of Ethics, laid out in Appendix B of the 2018-2019 ASNMSU Law Book, by any
15 ASNMSU official, under any circumstances.

17 BE IT FURTHER RESOLVED that the Senate of the Associated Students of New Mexico State University encourages all
18 departments and officials within ASNMSU to read the ASNMSU Code of Ethics and sign a statement acknowledging that
19 they have read and agree to follow the ASNMSU Code of Ethics.

21 BE IT FURTHER RESOLVED that copies of this resolution be sent to the New Mexico State University Dean of Students,
22 ASNMSU President, ASNMSU Chief of Staff, ASNMSU Chief Justice, ASNMSU Vice President, the President Pro
23 Tempore of the ASNMSU Senate, ASNMSU Fiscal Advisor, ASNMSU Director of Community Outreach and the ASNMSU
24 Advisor.

26 BE IT FURTHER RESOLVED by the Senate of the Associated Students of New Mexico State University that the Code of
27 Ethics, as expressed in Appendix B of the 2018-2019 ASNMSU Law Book, be amended with deleted material in [brackets]
28 and inserted material underlined as follows:

[B-2-9. If ever the ASNMSU Student Code of Conduct conflicts with the NMSU Code of Conduct, the
35 NMSU Code of Conduct shall prevail.]

37 **B-2-9 ADDRESS OF VIOLATION**

38
39 A. Should a complaint alleging a violation of these standards by an ASNMSU official while in a capacity
40 representing their office become known to any official, it shall be their duty to report such allegations
41 to:

43 1. Appropriate university officials:

44
45 a. The person to whom the individual whose conduct is in question directly reports to;

46
47 b. In the case of the ASNMSU Chief of Staff or the ASNMSU Chief Justice, the ASNMSU
48 President;

49
50 c. In the case of the ASNMSU President or the ASNMSU Vice President, the ASNMSU
51 Advisor;

52
53 d. In the case of the ASNMSU Advisor, the Dean of Students;

55 2. The ASNMSU Advisor;

56
57 3. The Dean of Students;

59 4. NMSU Office of Institutional Equity;

61 5. Any third party NMSU has selected as an anonymous way to confidentially report activities that
62 may involve criminal, unethical, or otherwise inappropriate behavior, including violations of
63 university policies and procedure;

65 **B-2-10. PRECEDENCE OF THE CODES OF CONDUCT**

67 If ever the ASNMSU Code of Ethics conflicts with the NMSU Code of Conduct, the NMSU Code of
68 Conduct shall prevail.
