1 CREATING THE ASNMSU LEADERSHIP CONFERENCE. BE IT ENACTED BY THE SENATE OF THE
2 ASSOCIATED STUDENTS OF NEW MEXICO STATE UNIVERSITY.

4 Section 1: Purpose of Act.

5 To add the ASNMSU Leadership Conference to the ASNMSU Law Book as recommended by the Winter
6 2018 Law Book Committee.

13 **6-4. ASNMSU LEADERSHIP CONFERENCE ACT**

14 **AN ACT ESTABLISHING THE ASNMSU LEADERSHIP CONFERENCE.**

16 **6-4-1. PURPOSE OF ACT**

17 To provide leadership development seminars for high school students and share with them the college
18 experience at NMSU and student government at ASNMSU.

19

20 **6-4-2. FREQUENCY**

21 There shall be one (1) conference held annually during the Spring semester.

22

23 **6-4-3. DIVISION OF RESPONSIBILITY**

24 The ASNMSU Executive Director of Community Outreach shall be responsible for the planning and
25 execution of the ASNMSU Leadership Conference. The planning shall include, but not be limited to,
26 setting the time, place and content of the conference.

27

28 **6-4-4. FUNDING**

29 A. ASNMSU shall be responsible for all expenses incurred in developing and producing the ASNMSU
30 Leadership Conference.

32 B. Conference expenses shall be appropriated through the account of Community Outreach during the
33 General Appropriations Act.

35 Section 3: Rationale.

36 The ASNMSU Leadership Conference has been put on under the last two administrations and has been a
37 successful way to teach leadership skills to high school students as well as show them NMSU and
38 ASNMSU. The Winter 2018 Law Book Committee determined that the conference should continue to be
39 put on annually in the coming years and felt that it should be formally established in the Law Book.
