




13 **3-21. ASNMSU ATTORNEY GENERAL**

17 **3-21-4. DUTIES AND RESPONSIBILITIES OF THE ASNMSU ATTORNEY GENERAL**

18 The duties and responsibilities that the ASNMSU Attorney General shall be expected to perform,
19 unless otherwise provided for by law are:

21 A. Represent ASNMSU in [all] cases before the ASNMSU Supreme Court in which
22 ASNMSU is a party of interest;

24 1. Should the ASNMSU Supreme Court or the ASNMSU President determine that the Attorney
25 General has a personal or pecuniary interest in the case, the ASNMSU President is responsible for
26 appointing counsel to represent ASNMSU.

28 2. Should the ASNMSU Supreme Court decide that the Attorney General has a personal or
29 pecuniary interest in the case of impeachment proceedings against the ASNMSU President or the
30 ASNMSU Vice President, the ASNMSU Supreme Court is responsible for appointing counsel to
31 represent ASNMSU.
